Resolution No. 2024-94Passed December 18, 2024

SPONSOR: MAYOR RICK

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A FIRST RENEWAL TO SUMMIT COUNTY-AKRON REGIONAL RADIO SYSTEM USER AGREEMENT TO EXTEND THE TERM OF THE SAME UNTIL APRIL 30, 2029, AND DECLARING AN EMERGENCY.

WHEREAS, the County of Summit and City of Akron own and operate the Summit County-Akron Regional Radio System to provide radio communications for public safety and public service needs; and

WHEREAS, the Village previously entered into the Summit County-Akron Regional Radio System User Agreement (the "Agreement"), effective as of May 1, 2019, for the use of said system; and

WHEREAS, the Agreement's initial term expired on April 30, 2024, with options for renewal; and

WHEREAS, the Mayor desires to renew the Agreement for an additional five-year term until April 30, 2029, a copy of the First Renewal of the Agreement is attached hereto as Exhibit A and incorporated herein by reference; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to authorize the Mayor to execute the First Renewal of the Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio as follows:

SECTION 1: The Mayor is hereby authorized and directed to execute the First Renewal of the Agreement in the form attached hereto as Exhibit A and incorporated herein by reference.

SECTION 2: That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately the First Renewal of the Agreement due to the prior expiration of the Agreement, and, provided this Resolution receives the affirmative vote of at least five (5) members elected or appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.

**FIRST RENEWAL
OF THE
SUMMIT COUNTY-AKRON
REGIONAL RADIO SYSTEM
USER AGREEMENT**

This First Renewal of the Summit County-Akron Regional Radio System User Agreement, effective May 1, 2024, is by and among the COUNTY OF SUMMIT, Office of the County Executive, 175 South Main Street, 8th Floor, Akron, Ohio 44308 (the "County"), as authorized by County Council Resolution No. 2018-381, and the CITY OF AKRON, Mayor's Office, Municipal Building, 166 South High Street, Akron, Ohio 44308 (the "City"), as authorized by City of Akron Ordinance No. 498-2005 (collectively, the "Owners"), and VILLAGE OF MOGADORE, with its principal place of business at 135 South Cleveland Avenue, Mogadore, Ohio 44260 ("User") (the Owners and User together, the "Parties").

RECITALS

WHEREAS, the Owners and User entered into the Summit County-Akron Regional Radio System User Agreement (the "Agreement"), effective as of May 1, 2019; and

WHEREAS, the Agreement's initial term expired on April 30, 2024, with options for renewal; and

WHEREAS, the Parties desire to renew the Agreement for an additional five-year term in accordance with the terms outlined in Section 4 of the Agreement.

NOW, THEREFORE, in consideration of the mutual promises contained herein, the parties agree as follows:

1. Renewal Term

The Agreement is hereby renewed for an additional term of five (5) years, commencing on May 1, 2024, and expiring on April 30, 2029, pursuant to the renewal option provided in Section 4 of the Agreement.

2. Terms and Conditions

All other terms and conditions of the Agreement shall remain in full force and effect, unless modified herein or in a subsequent written agreement signed by all Parties.

3. Updated Membership Fees

The membership fee for the renewal term shall be \$20.00 per month, per radio.

4. Notices

Notices for the renewal term shall continue to be sent to the addresses outlined in the original Agreement unless otherwise updated in writing by a party.

5. Acknowledgment of Renewal

By signing below, the Parties affirm their intention to continue their participation under the terms of the Agreement as renewed herein.

IN WITNESS WHEREOF, the parties have executed this Renewal Agreement for the Summit County-Akron Regional Radio System as of the date first written above.
