December 18, 2024

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A FIRST RENEWAL TO SUMMIT COUNTY-AKRON REGIONAL RADIO SYSTEM USER AGREEMENT TO EXTEND THE TERM OF THE SAME UNTIL APRIL 30, 2029, AND DECLARING AN EMERGENCY.

Van Dike made a motion to suspend the rules requiring three readings; Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Van Dike to adopt Resolution 2024-94; a second was made by Bauer.

Law Director, Mr. Dodson stated this piece of legislation is for the radios that are used by both Police and Fire Departments. The fee is \$20.00 per month per radio. The agreement expired back in April of this year. This is a renewal agreement for five years and the fee will stay the same for five years.

Vote. Unanimous ayes. Motion carried.

Ms. Van Dike presented Resolution 2024-95 sponsored by Finance Committee as follows:

A RESOLUTION CONFIRMING THE RE-APPOINTMENT OF SCOTT K. VARNEY AS CLERK-TREASURER OF THE VILLAGE, AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH VARNEY, FINK & ASSOCIATES, INC. TO PROVIDE ACCOUNTING SERVICES FOR THE VILLAGE, AND DECLARING AN EMERGENCY.

Van Dike made a motion to suspend the rules requiring three readings; Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Van Dike to adopt Resolution 2024-95; a second was made by Miller.

Mayor Rick reminded Council members this is only for the first three months of 2025.

Mr. McDowall presented Resolution 2024-96 sponsored by the Parks and Recreation Committee as follows:

A RESOLUTION REVISING THE FEE SCHEDULE FOR GREENWOOD CEMETERY, EFFECTIVE JANUARY 1, 2025, AND DECLARING AN EMERGENCY.

McDowall made a motion to suspend the rules requiring three readings; Van Dike seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by McDowall to adopt Resolution 2024-96; a second was made by Tonsic.

Mayor Rick thanked Rachel Osborne, June Long, and the rest of the cemetery board for their help.

Vote. Unanimous ayes. Motion carried.

Ms. Van Dike presented Resolution 2024-97 sponsored by the Finance Committee as follows:

A RESOLUTION AUTHORIZING THE TRANSFER OF FUNDS FROM THE GENERAL FUND TO THE STREET FUND AND THE PARK AND RECREATION FUND AND DECLARING AN EMERGENCY.

Van Dike made a motion to suspend the rules requiring three readings; Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Van Dike to adopt Resolution 2024-97; a second was made by McDowall. Vote. Unanimous ayes. Motion carried.

<u>COMMENTS from the Public</u>: Carl Housley, 67 First Avenue, asked what percentage of Phase 1 is done with the infrastructure.

Law Director, Mr. Dodson stated all the infrastructure in Phase 1 is done, and all or most of the underground in Phase 2 has been done.

Housley asked if all the work had been tested, approved, and ready to connect to.

Dodson, yes.

Jon Mencer, 242 South Cleveland Avenue, Mencer asked if soliciting permits are still required. Mencer stated a young man wearing a Spectrum hat was soliciting early today. When asked if he had a permit from the Village, he stated he did not need one and took off running.

Mayor Rick confirmed a permit is required to solicit in the Village and he would let Police Chief Higgins know to be aware of.
