SPONSOR: UTILITIES COMMITTEE

A RESOLUTION AUTHORIZING THE CLERK-TREASURER TO ADVERTISE FOR BIDS FOR EXCLUSIVE TRASH HAULING SERVICES WITHIN THE VILLAGE OF MOGADORE, AND DECLARING AN EMERGENCY.

WHEREAS, Chapter 50 of the Village's Charter provides that the collection and disposal of trash, garbage and rubbish, together with recycling (collectively, the "Trash Hauling Services"), by the Village is a public utility and that all residential units within the Village shall utilize, exclusively, the Trash Hauling Services of a contractor who is contracted with by the Village for said purpose after open competitive bid; and

WHEREAS, the Village previously entered into an agreement with Kimble Recycling & Disposal, Inc. ("Kimble") for exclusive Trash Hauling Services within the Village through March 31, 2026; and

WHEREAS, the Village has identified the need to secure new Trash Hauling Services upon expiration of the current agreement with Kimble; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village of Mogadore to advertise for bids for exclusive Trash Hauling Services within the Village.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

<u>SECTION 1</u>: It is hereby determined necessary that the Village enter into an exclusive contract for Trash Hauling Services within the Village, upon expiration of the current agreement with Kimble.

SECTION 2: The Clerk-Treasurer of the Village is hereby authorized and directed to advertise for bids for an exclusive contract for Trash Hauling Services within the Village in anticipation of the expiration of the current agreement with Kimble. A report of responses shall be provided to Council.

SECTION 3: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.
