A RESOLUTION AMENDING THE FULL-TIME FIREFIGHTER HANDBOOK TO PROVIDE FOR REVISIONS TO THE FUNERAL LEAVE AND PARENTAL LEAVE FOR FULL-TIME FIREFIGHTERS IN THE VILLAGE, AND DECLARING AN EMERGENCY.

Ms. Van Dike presented Resolution 2025-25 Sponsored by Finance Committee as follows:

A RESOLUTION AUTHORIZING THE TRANSFER OF FUNDS FROM THE GENERAL FUND TO THE CEMETERY FUND, FIRE FUND, STREET FUND, AND THE PARK AND RECREATION FUND AND DECLARING AN EMERGENCY.

A motion was made by Van Dike to adopt Resolution 2025-25; a second was made by Bauer. Vote. Unanimous ayes. Motion carried.

Ms. Van Dike presented Ordinance 2025-26 Sponsored by Mayor Rick as follows:

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE FOR THE FISCAL YEAR ENDING DECEMBER 31, 2025, AND DECLARING AN EMERGENCY.

Van Dike made a motion to suspend the rules requiring three readings; Tonsic seconded the motion. Vote. Unanimous ayes. Motion carried.

A motion was made by Van Dike to adopt Ordinance 2025-26; a second was made by McDowall. Vote. Unanimous ayes. Motion carried.

<u>COMMENTS from the Public</u>: Carl Housley, 67 First Avenue, asked questions regarding property tax collected on Fire/EMS Levey, and asked if the Village has applied for a new SAFER Grant. Mayor Rick responded.

*Don Smith, 3851 Louise Street,* asked when the new homes will be built at the West Village Development. Law Director Jason Dodson provided an update on the status.
