A RESOLUTION ALLOWING THE MAYOR TO APPLY FOR FEDERAL SURFACE TRANSPORTATION BLOCK GRANT FUNDS PROGRAMMED BY THE AKRON METROPOLITAN AREA TRANSPORTATION STUDY TO IMPROVE THE STATE ROUTE 532 AND MOGADORE ROAD INTERSECTION AND DECLARING AN EMERGENCY.

WHEREAS, the Village Engineer has recommended that the Village apply for federal Surface Transportation Block Grant ("STBG") funds programmed by the Akron Metropolitan Area Transportation Study to improve the State Route 532 and Mogadore Road Intersection; and

WHEREAS, this Council finds and determines that it is necessary, and in the best interest of the Village to authorize the Mayor to apply for said STBG funds to improve the State Route 532 and Mogadore Road Intersections.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Portage and Summit, Ohio, that:

<u>SECTION 1:</u> The Mayor is hereby authorized to apply for federal STBG funds programmed by AMATS to improve the State Route 532 and Mogadore Road Intersection, as follows:

<u>SECTION 2</u>: The Village acknowledges and understands the AMATS "Funding Policy Guidelines" and confirms to the best of its knowledge that the information contained in the project application is accurate, that it intends to diligently pursue that project, and that a local share is required to match federal funds.

SECTION 3: It is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
