Resolution No. 2025-73Passed December 3, 2025

SPONSOR: UTILITIES COMMITTEE

A RESOLUTION ACCEPTING THE BID OF KIMBLE RECYCLING & DISPOSAL, INC. TO PROVIDE EXCLUSIVE RESIDENTIAL TRASH REMOVAL AND RECYCLING SERVICES WITHIN THE VILLAGE FOR THE PERIOD OF APRIL 1, 2026 TO MARCH 31, 2029, WITH TWO ONE-YEAR OPTIONS TO EXTEND, AND DECLARING AN EMERGENCY.

WHEREAS, Section 13.01 of the Village's Charter provides that this "Council may, by legislation approved by five (5) members, grant an exclusive franchise/contract to any person, firm, or corporation to operate, maintain and/or provide trash removal and/or recycling services within the Municipality or any extension thereof for a period of not more than twenty-five (25) years;" and

WHEREAS, the Village's current agreement for residential trash removal and recycling services expires on March 31, 2026; and

WHEREAS, the Mayor and Clerk-Treasurer have solicited bids from firms to provide trash removal and recycling services for the period of April 1, 2026 to March 31, 2029, with two one-year options to extend, and have received several responsive bids; and

WHEREAS, after review of the bids, the Utilities Committee has recommended that Kimble Recycling & Disposal, Inc. ("Kimble") has submitted the lowest and best bid, and that the award of the aforementioned agreement to Kimble is in the best interest of the Village; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to accept the aforementioned bid from Kimble as the lowest and best bid for the residential trash removal and recycling services within the Village and to further authorize the Mayor to enter into a contract with Kimble for such residential trash removal and recycling services for the period of April 1, 2026 to March 31, 2029, with two one-year options to extend.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The bid for residential trash removal and recycling services from Kimble for the period of April 1, 2026 to March 31, 2029, with two one-year options to extend, is hereby accepted and determined to be the lowest and best bid, and in the best interest of the Village. Accordingly, Kimble is awarded an agreement to provide residential trash removal and recycling services within the Village for the period of April 1, 2026 to March 31, 2029, with two one-year options to extend.

SECTION 2: The Mayor is hereby authorized and directed to execute an agreement with Kimble to provide residential trash removal and recycling services within the Village for the period of April 1, 2026 to March 31, 2029, with two one-year options to extend.

SECTION 3: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 4: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately authorizing the Mayor and Clerk-Treasurer to execute the aforementioned contract prior to the expiration of the existing agreement and to further provide certainty in trash removal and recycling services within the Village, and, provided this Resolution receives the affirmative vote of at least five (5) members elected or appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.
