A RESOLUTION CONFIRMING THE RE-APPOINTMENT OF LINDA SANSOM TO THE VILLAGE CEMETERY BOARD FOR THE TERM OF JANUARY 1, 2026 TO DECEMBER 31, 2028, AND DECLARING AN EMERGENCY.

McDowall made a motion to suspend the rules requiring three readings; seconded by Tonsic. Vote. Unanimous ayes. Motion carried.

A motion was made by McDowall to adopt Resolution 2026-1; seconded by Bauer. Vote. Unanimous ayes. Motion carried.

Tonsic presented Resolution **2026-2**, Sponsor: Streets Committee:
A RESOLUTION AUTHORIZING THE MAYOR, CLERK-TREASURER AND VILLAGE ENGINEER TO PREPARE AND SUBMIT AN APPLICATION FOR FUNDS FROM THE OHIO PUBLIC WORKS COMMISSION FOR KAVANAUGH DRIVE, KESTER AVENUE AND CURTIS STREET PROJECT, TO PARTNER WITH THE COUNTY OF SUMMIT AND/OR CITY OF AKRON TO PARTIALLY FUND THE PROJECT, AND TO EXECUTE AGREEMENTS AS REQUIRED TO EFFECTUATE THE SAME, AND DECLARING AN EMERGENCY.

Tonsic made a motion to suspend the rules requiring three readings; seconded by Van Dike. Vote. Unanimous ayes. Motion carried.

A motion was made by Tonsic to adopt Resolution 2026-2; seconded by Miller. Vote. Unanimous ayes. Motion carried.

Miller presented Ordinance **2026-3**, Sponsor: Planning & Zoning Committee:
AN ORDINANCE AMENDING SECTION 152.052 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF MOGADORE, ENTITLED “PUD PLANNED USE DEVELOPMENT-MIXED DISTRICT” TO REDUCE THE REAR YARD SETBACK FOR TOWNHOUSES AND CONDOMINIUMS WITHIN APPLICABLE DISTRICTS, AND DECLARING AN EMERGENCY.

Miller made a motion to suspend the rules requiring three readings; seconded by McDowall. Vote. Unanimous ayes. Motion carried.

A motion was made by Miller to adopt Resolution 2026-3; seconded by Bauer. Vote. Unanimous ayes. Motion carried.

COMMENTS from the Clerk-Treasurer: Scott Varney was not in attendance.


COMMENTS from Mayor Rick: Mayor Rick had no comment.
