A RESOLUTION AMENDING RESOLUTION NO. 2025-83 CONCERNING THE COMPENSATION AND BENEFITS FOR THE FULL-TIME POLICE DEPARTMENT ADMINISTRATIVE ASSISTANT/MAYOR'S COURT CLERK, AND DECLARING AN EMERGENCY.

WHEREAS, Section 3.10(D) of the Village's Charter provides this Council with the authority to establish and determine the compensation of the employees of the Village; and

WHEREAS, the Mayor has recommended revising the compensation of the Police Department Administrative Assistant/Mayor's Court Clerk to be stated as hourly compensation; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to revise the compensation of the Police Department Administrative Assistant/Mayor's Court Clerk.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: Resolution No. 2025-83 is hereby amended to state as follows:

The compensation for the position of full-time Police Department Administrative Assistant/Mayor's Court Clerk shall be \$20.41 hourly, which shall be payable bi-weekly.

SECTION 2: The employment benefits to be provided to the Police Department Administrative Assistant/Mayor's Court Clerk shall be the same as those provided other full-time employees of the Village other than the full-time Police Department and Fire Department employees, with the exception of the uniform allowance.

SECTION 3: This Resolution shall be retroactively effective to December 27, 2025. Any provisions of any prior Resolution or Ordinance that are inconsistent herewith are hereby rescinded in their entirety.

SECTION 4: The Village of Mogadore finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements

SECTION 5: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately revising the pay of the Police Department Administrative Assistant/Mayor's Court Clerk to be consistent with practices of the Village, and, provided this Resolution receives the affirmative vote of at least five (5) members elected or

appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.
