A RESOLUTION AMENDING RESOLUTION NO. 2025-75 CONCERNING THE COMPENSATION AND BENEFITS PROVIDED BY THE VILLAGE TO THE FIRE CHIEF, AND DECLARING AN EMERGENCY.

WHEREAS, Section 3.10(D) of the Village's Charter provides this Council with the authority to establish and determine the compensation of the employees of the Village; and

WHEREAS, the Mayor has recommended revising the compensation of the Fire Chief to be stated as hourly compensation; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village to revise the compensation of the Fire Chief.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: That Section 1 of Resolution 2025-75 shall be amended as follows:

The compensation for the position of full-time Fire Chief shall be \$45.48 hourly, which shall be payable bi-weekly. In addition, the Fire Chief shall receive an annual clothing and equipment allowance of \$1,500.00.

SECTION 2: The employment benefits to be provided to the full-time Fire Chief shall be the same as those provided to other full-time firefighters of the Fire Department. Said benefits shall be set forth in the Full-Time Firefighter Handbook.

SECTION 3: This Resolution shall be retroactively effective to December 27, 2025. Any provisions of any prior Resolution or Ordinance that are inconsistent herewith are hereby rescinded in their entirety.

SECTION 4: The Village of Mogadore finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 5: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of immediately revising the pay of the Fire Chief to be consistent with practices of the Village, and, provided this Resolution receives the affirmative vote of at least five (5) members elected or appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.
