A RESOLUTION AUTHORIZING THE VILLAGE OF MOGADORE TO APPLY FOR AND ACCEPT A GRANT FROM THE OHIO DEPARTMENT OF NATURAL RESOURCES RECREATIONAL TRAILS PROGRAM TO SUPPORT PHASE IV OF THE TRAIL IN LIONS PARK, AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Department of Natural Resources (“ODNR”) Recreational Trails Program has made, or will make, funds available to political subdivisions for certain capital improvements to recreational trails within Ohio; and

WHEREAS, the Village has implemented various enhancements within Lions Park in recent years, including the phased improvement and extension of the recreational trail within Lions Park;

WHEREAS, the Village desires to apply for, and accept, grant funds from ODNR’s Recreational Trail Program to fund capital costs for the next phase, Phase IV, of the recreational trail improvements in Lions Park; and

WHEREAS, the Village will provide the local funds necessary to meet any matching funds requirement of ODNR’s Recreational Trails Program; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the Village of Mogadore to apply for and accept a grant from the ODNR Recreational Trails Program to support Phase IV of the recreational trail improvements in Lions Park.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Mogadore, Counties of Summit and Portage, State of Ohio, that:

SECTION 1: The Mayor and all other Village officials are hereby authorized to do all things necessary to apply for a grant from the Ohio Department of Natural Resources Recreational Trails Program to support Phase IV of the recreational trail improvements in Lions Park.

SECTION 2: The Mayor and all other Village officials are hereby authorized to do all things necessary to accept a grant from the Ohio Department of Natural Resources Recreational Trails Program to support Phase IV of the recreational trail improvements in Lions Park.

SECTION 3: The Mayor is further authorized to sign any and all documents and/or agreements on behalf of the Village as may be necessary and appropriate for Phase IV of the recreational trail improvements in Lions Park upon acceptance of the grant funds.

SECTION 4: To the extent not already done so, the funds required for payment of the obligations incurred by the Village incurred herein are hereby appropriated.

SECTION 5: This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in this formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION 6: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the residents of the Village of Mogadore and for the purpose of applying for and accepting the aforementioned grant in a time and manner required by the grant program, and, provided this Resolution receives the affirmative vote of at least five (5) members elected or appointed to this Council, it shall take effect and be in force upon its passage by Council and approval by the Mayor, otherwise it shall take effect and be in force at the earliest period allowed by law.
